GENERAL INFO:

- ✘ Reservations are required for both doggy daycare and overnight boarding. Ask us about our online reservation system!
- ✘ Please call ahead or we may regrettably have to turn you away.
- ✘ The half day daycare rate is valid for 5 consecutive hours or fewer.
- ✘ Dogs must be ON LEASH in the office and in the parking lot for their safety.
- ✘ All dogs must be current on all vaccines: DHPP, Rabies, and Bordetella. Bordetella is required every 6 months, so please keep us updated with your current dates.
- ✘ Dogs not picked up by 6:30pm may be boarded overnight at owners' expense.
- ✘ Late fees (\$1 for 5 minutes) may apply.

- ✘ If your dog's nails are long, we may trim them at your expense for safety reasons.
- ✘ We take pictures of dogs every day and post them to our blog! Visit <http://divinecanine.blogspot.com> to see if you can spot your dog!

BOARDING INFO:

- ✘ A \$50 non-refundable deposit is required for boarding reservations. The fee will be applied to your dog's stay.
- ✘ Boarding dogs picked up after 12pm will be charged for a 1/2 day of daycare.
- ✘ Please bring food for your dog. Do not bring bowls.

- ✘ Please keep beds at home - we have Kuranda raised orthopedic beds and soft fleece mats for everyone.

- ✘ Christmas Day (12/25)

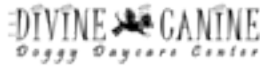

12. Is there any place on your dog's body where s/he does not like to be **touched**?

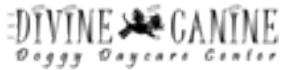

The Divine Canine LLC Services Agreement

Thank you for choosing the Divine Canine LLC's services. The following is a binding Agreement between _____, hereinafter "**Guardian**" and **The Divine Canine LLC** located at 2103 N. 96th Street, Louisville, Colorado, 80027.

This Agreement is made this day by and between Guardian and The Divine Canine LLC, hereinafter "Divine Canine", both of whom are somethings collectively referred to herein as "the parties".

Now therefore, in consideration of the mutual promises, covenants, conditions, and payments of money set forth herein, Divine Canine and the Guardian hereby agree as follows:

1. Responsibilities

- 1.1. Divine Canine agrees to maintain its license to provide pet animal care with the Colorado Department of Agriculture during the term of this Agreement
- 1.2. Guardian agrees to notify Divine Canine of any unwelcome, aggressive, procreative, or dangerous behavior of the dog that has potential to cause harm to any other pet or individual.
- 1.3. Guardian agrees to notify Divine Canine of any infection, contagious, or pre-existing diseases or conditions. Guardian is responsible for the mental and physical wellbeing of the dog(s). Such illnesses and conditions include Distemper, Hepatitis, Leptospirosis, Canine Cough, Parvovirus, Coronavirus, Heart-worm, Lyme Disease, Rabies, fleas, ticks, pregnancy, infectious skin diseases, intestinal parasites, or cancer.
- 1.4. Divine Canine will, to the best of its ability, provide a premises free of man-made hazards other than those arising out of the required fencing, gates, water bowls, toys, and other structures necessary for the care of the pets; or naturally occurring hazards such as sticks, stones, and insects.
- 1.5. Guardian is responsible for any non-negligent injury, loss, or death to the dogs by fire, theft, escape, or natural phenomenon including, but not limited to injuries from other animals suffered while interacting with other dogs, which may include young pups that have not been spayed or neutered. Divine Canine is not responsible for the pregnancy of any un-spayed female dog on or off premises.
- 1.6. Guardian understands and agrees that any dog(s) that are unclaimed for (7) seven or more days after scheduled term of care has ended will be considered abandoned. Abandoned dogs will be re-homed or delivered to a local humane shelter or rescue group.
- 1.7. Guardian agrees and understands that Divine Canine may discipline the dogs as required. Corrective measures may include, but are not limited to,

tethering, crating, and spraying with water bottle.

- 1.8. Guardian understands and agrees that dogs will interact and co-mingle with other dogs during their stay at Divine Canine.
- 1.9. Divine Canine is not responsible for any lost, stolen, or destroyed toys, leashes, collars, beds, tags, clothing or any other item left with the dog.
- 1.10. Divine canine reserves the right to refuse service to any dog at any time.

2. Pet Health and Protection

- 2.1. Dog must be current on all vaccinations for Distemper, Parvovirus, Rabies, and Canine Cough, also known as bordetella. Adequate antibody levels proven by titer testing will also be acceptable proof of protection.
- 2.2. Guardian must continue any necessary efforts to insure that his/her dogs are free of contagious, infectious, or otherwise communicable diseases. Regardless of scheduled days, Guardian must report to Divine Canine before arriving any contagious diseases and WILL NOT be allowed to bring the dogs to Divine Canine until the condition is resolved. Resolution is determined by Divine Canine.
- 2.3. In the case of injury or illness, Divine Canine will contact Guardian and/or Guardian's designated emergency contact. Guardian's designated veterinarian may also be contacted at the discretion of Divine Canine. Guardian understands and agrees that regardless of designated veterinarian, Divine Canine may use its choice of veterinarian. Guardian or his/her agent will be responsible for all veterinary care bills. This Agreement represents permission from Guardian for any licensed veterinarian to carry out any procedure deemed necessary with or without the presence of Guardian or his/her agent.
- 2.4. In the case of death of a dog on the premises, Divine Canine will contact Guardian, and if necessary, the dog will be brought to either a designated veterinarian or a veterinarian at the choice of Divine Canine to await further instructions from guardian.
- 2.5. Guardian understands and agrees that their dogs will be kenneled or crated on the premises or during transportation.
- 2.6. Guardian understands and agrees that it is his/her responsibility to keep dogs nails trimmed short to avoid injury from torn nails or scratches to other dogs. Guardian understands and agrees that Divine Canine may trim dogs nails at Guardian's expense if deemed necessary.

2.7. Guardian understands and agrees that his/her dogs may be kenneled off premises, at Guardian’s expense for health or behavioral reasons.

3. Waiver of Liabilities

3.2. Guardian, hereby for him/herself, his/her heirs, administrators and assigns, releases and discharges the owners, operators, and sponsors of Divine canine and their respective servants, agents, actions and causes of action for all such injuries and damages.

3.3. By signing this Agreement, Guardian agrees to assume all risks and responsibilities for him/herself, guests, and property including the dogs while at Divine Canine or any activities sponsored by Divine Canine. Guardian will be responsible for any damages incurred.

3.4. Guardian, family, friends, and guests understand and accept the inherent risks in encumbering themselves in this Agreement.

3.5. Guardian understands and agrees that, except in the even of Divine Canine’s wanton and willful negligence, Guardian is responsible for bodily injury or property damage that he/she or his/her dog(s) should sustain or cause while in the care of Divine Canine and for medical expenses incurred because of such bodily injury or property damage.

4. Miscellaneous

4.3. Guardian shall comply with all rules, laws, ordinances, and governmental regulations applicable. Failure by Guardian to comply with applicable rules, laws, ordinances, and regulations will be grounds for termination of this Agreement at the discretion of Divine Canine.

4.4. If Divine Canine shall bring suit to collect any fees or costs for services or enforcing any provision of the Agreement, the successful party shall be entitled to an award of reasonable attorney’s fees in addition to other damages.

4.5. No assent, express or implied, to any breach of any one or more the of the agreements hereof shall be deemed or taken to be a waiver of any succeeding or other breach.

4.6. This agreement shall be binding on the parties, their agents, the owner, successors, or other assigns.

4.7. Guardian agrees that photos of his/her dog(s) and/or likenesses may be used in publications or advertisements without any compensation.

4.8. Returned checks are subject to a \$25 fee.
